The SL-45DC PRO and the SW-320DC PRO will have warranty for a period of five (5) years in residential installations. The TORO24 & MACH PRIME will have warranty for a period of four (4) years in residential installation and a period of three (3) years in commercial installations. The SL-175DC and the SW-375DC will have warranty for a period of five (5) years in III & IV UL class installations. The above operators, within their warranty period, are to be free from defects in circuitry, motor, gearbox and workmanship. This warranty begins from the date of purchase to the original owner.
